

The total approved cost in the grant is \$409,800.00 with a federal share of \$368,820.00, a state share of \$16,392.00, and a local share of \$24,588.00.

This grant was originally submitted to GEMA/HS in 2021 for approval. Despite the grant being awarded in 2024, the amount is still awarded on those 2021 numbers. Based on current pricing quotes the County would be responsible for an additional \$92,419.00. This would bring the County's total share of the project to \$117,007.00.

There is a possibility of receiving additional funding to offset that increase, however that will not be announced until the statewide grant is closed out for all jurisdictions. If there is any money returned to the state from the other award recipients, it will be made available.

The budget line for the County's share will be 505-4400-11.7500.

I would ask the grant agreement for the HMGP 4579-0009 be added to the next Commissioners agenda and reviewed for approval.

Over the last five months the Purchasing Warehouse inventory has been thoroughly reviewed. In doing so, items have been identified as obsolete and/or expired. Purchasing would like the permission to dispose of \$9,665.40 worth of items that are no longer used by the county or are expired. The items, that are not expired, will be put in the Annual Surplus Auction to try and recoup some of the lost funds. Attached is a breakdown.
