House District 143 redistricting is complete. The polling location cards have been ordered.

Debra Presswood spoke with the Roads and Bridges Department about placing signs for the polling location moves. Message board signs will be put in placed one week in advance of the March 12, 2024 Election. The signs will be placed at Houston County Career and Tech Center (HCTC), Veteran of Foreign War (VFW), Rozar Park (ROZR) and Perry Event Center (PEC). New polling location cards were mailed for both moves.

We began mailing ballots to Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA) voters on January 23, 2024. We will begin mailing all other ballots as of February 12, 2024.
