The Municipalities Street Maintenance Check is complete.

Precinct cards for Perry Event Center (PEC), new polling location, will be mailed after the municipalities elections to avoid polling locations confusion. Perry Event Center location is effective 2024.

Reminder: Municipal Qualifying is August.

The Secretary of State has set-up physical site assessments for all county election equipment facilities. The Department of Homeland Security (DHS) and the Georgia Emergency Management Agency (GEMA) are working together to execute this important exercise.
